#### Adult Living for Transitional Achievement (ALTA)

ALTA provides temporary housing, reentry support services, and skills development for youth returning to the community following a placement in a secure facility. The goal of ALTA is to reduce recidivism by helping youths to successfully reintegrate into the community following out-of-home-placement.

#### Case Management

Case management services are provided to all delinquent youth placed in JJYS custody. On a daily basis, a case manager makes placement decisions, monitors progress, helps determine consequences for non compliance with rules, shoulders responsibility for the documentation required for the Division to collect federal entitlement payments, coordinates with providers, communicates with the youth's family, and represents the Division in court. Case Management services continue after youth are released from a secure facility.

The goal of Day Skills Intervention is to reduce recidivism by helping youths acquire the skills to successfully function in their homes, schools, and communities.

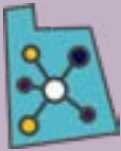

The goal of Gemstone is to reduce recidivism and risk by assisting youths to successfully implement their needs assessment service plan.
