## **Youth Services Programs & Services**

## Detention:

Locked Detention provides short-term locked confinement for delinquent youths awaiting adjudication, placement, or serving a sentence as ordered by a Juvenile Court Judge.

### Home Detention:

Home Detention is a community alternative to secure detention for pre-adjudicated youths waiting for final disposition of their current charges.

## Juvenile Receiving Centers:

Juvenile Receiving Centers (JRC) are located across the state for law enforcement officers to drop off arrested, delinquent, ungovernable, or runaway youth who do not meet admission guidelines for secure detention.

## School-Based Outreach:

School based services are designed to improve a youth's attendance and academic performance as well as teach prosocial skills such as problem solving, peer refusal, and anger management.
